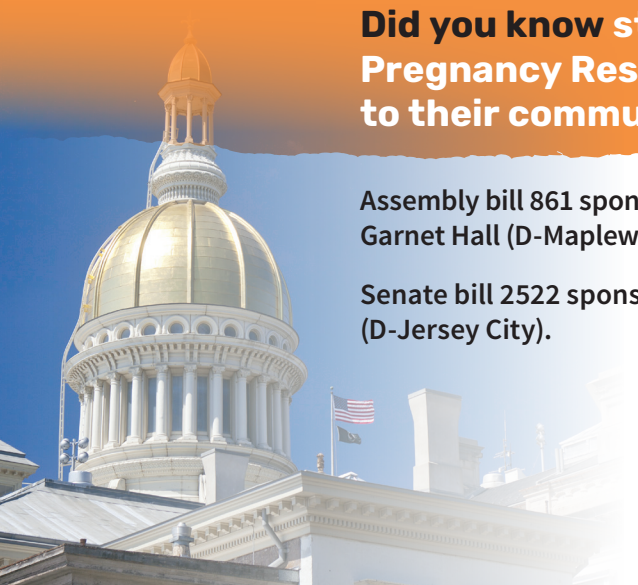

Did you know state legislators have introduced a Bill to prohibit Pregnancy Resource Centers from offering their free services to their community?

Assembly bill 861 sponsored by Verlina Reynolds-Jackson (D-Trenton), Ellen Park (D-Englewood), Garnet Hall (D-Maplewood), Herb Conaway (D-Delran) was introduced on Jan 9, 2024.

Senate bill 2522 sponsored by Shirley Turner (D-Ewing), Teresa Ruiz (D-Newark), Raj Mukherji (D-Jersey City).

Their free comprehensive pregnancy services include:

- Parent education and resources
- Reproductive grief support
- Peer counseling and education
- Maternity clothing
- Baby supplies (diapers, baby wipes, formula, clothing, blankets, and more)
- Support groups
- Healthy family support
- Emotional support
- Options information (providing accurate, fact-based information on abortion, adoption, and parenting)
- Information on natural family planning

Those that are licensed medical centers also may provide:

- Urine based pregnancy testing
- Ultrasound examinations
- Medical referrals
- Options information (providing accurate, fact based information on abortion, adoption, and parenting, early prenatal care, std testing)³

Did you know the Attorney General's office and the Division of Consumer Affairs have not provided any complaints registered with their offices that would have caused them to issue their consumer alert that stigmatized these life-affirming clinics?

The records custodian for the Attorney General's office and the Division of Consumer Affairs stated no complaints exist against the pregnancy resource centers.⁴



New Jersey Family Policy Center believes the Murphy Administration is seeking to serve their Abortion Industry donors at the expense of the women of New Jersey. They have decided to attack pregnancy resource centers with damaging lies and insults, create a tax payer funded Reproductive Health Care website that intentionally rejects any mention of adoption or parenting programs that are widely available, and have granted \$15 million to the Abortion Industry to renovate their clinics as if it is a tourism industry needing to be revitalized by government cash flow. Women deserve to know the risks of abortion and be informed about the alternatives available to them through state and non-profit programs.
